# RMGC Bylaws

## **NAME:**

Reno Men's Golf Club (Home Club Washoe Golf Course)

## **OBJECTIVE:**

Promote golf, knowledge of the rules of golf, good sportsmanship, and social activities among the membership and invited guests.

## **MEMBERSHIP:**

Open to male golfers who are or become 14 years old (or older) during the current fiscal year (ending December 31). Some special limitations are outlined for members 14 to 18 years of age as outlined in the rules and regulations. Memberships are not transferable.

## **BOARD OF DIRECTORS:**

- 1) The Board of Directors shall consist of no more than Twelve (12) Directors and they are requested to serve a minimum of two (2) years.
- 2) Must be a member of RMGC in good standing.
- 3) A member of the Board of Directors may be removed by a vote of two-thirds (2/3) of the Board.
- 4) Any vacancy may be filled by the Board of Directors.
- 5) One member on the Board shall be designated as Handicap Chair.
- 6) All matters relating to and governing RMGC will be the sole responsibility of the RMGC Board of Directors.

## **Bylaws Continued**

- 7) Anything that may arise not directly or indirectly covered in the RMGC bylaws shall be resolved by the Board of Directors.
- 8) The Board of Directors must attend two-thirds (2/3) of the scheduled meetings unless otherwise excused, if not excused it will be considered a self resignation and the Board of Directors may fill the vacancy.

### **BOARD/NOMINATIONS:**

- 1) Members will be given the opportunity to submit a request for any board member vacancy for consideration by the board.
- 2) The existing Board of Directors will select the candidates for the Board vacancies.
- 3) The Board will notify the membership of any new Board members to the membership via the official bulletin board and at the annual meeting/dinner.
- 4) Those selected will assume their duties beginning immediately.

### **GENERAL MEMBERSHIP/DINNER/MEETING:**

There will be one general membership dinner/meeting held in the spring of each year. Any major changes taken by the Board during the previous year will be shared with the general membership.

# **Bylaws Continued**

## **MEETINGS/QUORUM**

Board of Directors:

- 1) Meetings: Meetings will be called at the discretion of the Board President, usually the first Tuesday of the month in the board room at Washoe Golf Course. All members in good standings are invited to attend board meetings provided they notify a board member in advance of the meeting.
- 2) Quorum: Will consist of a majority of the Board.

## **INFORMATION/NOTICES:**

RMGC will utilize email and our website for information and notices. The website [washoegolf.org](http://washoegolf.org) is RMGC official bulletin board.



# USGA & Local Rules

- 1) **Summer Rules:** Play the ball down for all Tournaments.
- 2) **Winter Rules: (Will be posted when applicable)** Lies may be improved six inches through the green – defined as the whole area of the course except:
  - a. Teeing ground and putting green of the hole being played
  - b. All hazards on the course.
- 3) **Lost Ball:** Stroke & distance penalty - Rule 27
- 4) **Embedded Ball:** A ball embedded in its own pitch mark “through the green” may be lifted, cleaned and dropped without penalty, no nearer the hole.
- 5) **Putting Green:** You may repair old hole plugs and ball marks.  
Rule 16-1c
- 6) **Penalty Areas:** One stroke penalty assessed
  - a. **Water Hazards:** Holes #3 and #8 Rule 26
  - b. **Lateral Water Hazards:** All other lakes and irrigation ditches (Red Stakes) Rule 26
- 7) **Out of Bounds:** Stroke and Distance - Rule 27
  - a. White stakes left of #1, #7 and #14
  - b. Fence behind #9 and #18
  - c. Parking lot right of #10
  - d. Practice putting green
  - e. White stakes behind #14
  - f. All course boundary fences
  - g. Fence line - right side of #10 fairway.

## USGA & Local Rules

- 8) **Stroke Play—Doubt of Procedure:** Play a second ball. Play out both balls and report to the Rules Committee immediately upon completing the round. Rule 3-3
- 9) **Free Drop Areas:** No penalty. Drop ball one club length, nearest the point of relief—**NO NEARER THE HOLE**
- a. Parallel fairway boundary ditches (drop in rough)
  - b. Concrete wall right of #10
  - c. Protective fences behind #10 green and left of #14 (if on fairway side of fence)
  - d. Roads and cart paths
  - e. Staked or tagged trees
  - f. Ground under repair (wet/dry):
    1. Equipment and cart ruts
    2. Newly seeded or aerated areas
    3. Large bare areas in your own fairway
    4. Drainage areas middle of fairway on #13 and #14 (French drains)

**Waste Bunkers:** Fairway bunkers on holes #4 and #15 are regular sand bunkers and must be played as such.

# Tournaments

USGA rules will govern all play except as modified by local rules or such temporary rules posted.

## Score Cards

- 1) First and last name (legible) per card plus GHIN number and handicap (exception-team events-see #2)
- 2) Team Events: First and last names, GHIN numbers and handicap of each player
- 3) Scorecards are exchanged prior to play. You will be keeping the score for another person in your foursome
- 4) All scores must be dated, signed and attested.
- 5) Incomplete or unreadable cards may be disqualified

## Tournament Flights and Tees

- 1) When a tournament has over 50 players, three equally divided flights will be used.

### *Three flight tournament tees -*

Flight 1 will utilize black tees, Flight 2 will utilize silver tees, Flight 3 will utilize white tees. Players 70 years of age or over in flight 3 have the option of playing from gold tees.

- 2) When a tournament has 50 players or less, two equally divided flights will be used.

### *Two flight tournaments tees*

The Flight #1 will utilize the silver tees, Flight #2 will utilize the white tees. Players 70s of age or over in flight 2 have the option of playing from gold tees

- 3) A player qualified and taking the option to play from the gold tees must notify the pro shop on the tournament application form.

## Tournament Entry fees

- 1 The weekend tournaments will have a \$25 entry fee. Of that fee \$20 will go to the prize fund for that tournament. The remaining \$5 will go to the general fund of the Men's Club and will subsidize future prizes, Junior Golf, course improvements and community outreach.
2. Tournament Entries are due 36 hours prior to each event with payment in full. For Saturday Tournaments, the deadline will be 5PM the Thursday prior to the event. For Sunday Tournaments, the deadline will be 5PM the Friday prior to the event. Cancellations after the deadline will not be refunded nor will they be carried over to a future event. No exceptions.  
  
The Wednesday Tournaments will have a \$10 buy in. Participants do not have to be an RMGC member to participate. Varying formats will be played with gross/net payouts in most cases
- 3 All the entry fees are subject to change as determined by the

## Posting Scores

The Handicap Committee will post scores for RMGC sponsored events only. Members are responsible for Equitable Stroke Control (ESC) adjustments. Members are also responsible for posting all other scores Including Monday and Wednesday Games.

RMGC members are expected to post all completed 18 hole rounds of stroke play throughout the year as governed by USGA posting Procedures. Failure to do so could result in Committee action."

# Handicapping for Tournament

1. **Individual** competition including match play should use full handicap.

2. **Best Ball** should be hole by hole with popped cards and partial handicap.

2 - Person 85%

3 - Person - 2 Best Ball 90%

4 - Person - 2 Best Ball 85%

3. **Shamble** should be hole by hole with popped cards and partial handicap.

2 - Person 80%

3 - Person - 2 Best Ball 85%

4 - Person - 2 Best Ball 80%

4. **Scramble** should be partial handicap and require drives for each player.

2- Person 1/4 total team handicap  
4 drives per person required

3 - Person 1/5 total team handicap  
3 drives per person required

4 - Person 1/6 total team handicap  
2 drives per person required

## RMGC Club Championship

RMGC will host an annual Club Championship and name both a Gross and a Net Club Champion.

### **Requirements to participate in the RMGC Club Championship Tournament**

1. Be a member in good standing in the Reno Men's Golf Club
2. Have played in a minimum of two RMGC Weekend Individual Gross/Net Tournaments in the current year.
3. Have an established USGA handicap.
4. Junior members not allowed to participate in Club Championship. Junior members will participate in a Junior member flight.

# Tournament Formats

## **2 MAN SCRAMBLE:**

Both players will tee off. Pick best drive. Both will play from within one club length from that ball, no closer to the hole. Continue in the same manner until ball is holed out. Subtract 1/2 of partners' combined handicaps for NET score.

## **3 PERSON in a BOX:**

Players will rotate "Man in the box" hole after hole. The Man in the Box score and the other best ball will be used for the team's best 2 ball score.

## **4 CLUB LOW NET:**

Can only use 4 clubs in complete round. Putter counts as one club.

## **4 MAN 2 BEST BALL:**

Record the two lowest GROSS and the two lowest NET scores per hole. May use the same balls to record GROSS and NET score.

## **BLIND DRAW:**

Everyone in the group plays a round of golf and calculates their Net score. Pairs of golfers are then drawn randomly and the best aggregate net score wins .

## **STABLEFORD POINTS TOURNAMENT:**

Points are awarded for your score on each hole on either a net or handicap basis. 1 point for a bogey; 2 points for a par; 3 points for a birdie; 4 points for an eagle and 5 points if you bag an

## **2 MAN BEST BALL:**

Stroke play. Pop your card according to Assignment of Strokes. Record the lowest GROSS and the lowest NET score per hole.

## More Tournament Formats

### **2- MAN NO SCOTCH:**

In the 2-Man No Scotch golf tournament format, team members tee off, then switch golf balls. They play their second strokes (each hitting the other's tee ball), then beginning with the third shot the two team members play out the hole as a scramble. The low ball (low score among the two players) is recorded as the team score for each hole

### **2-MAN 6-6-6:**

Holes 1 – 6 played best ball; holes 7 – 12 played scramble; holes 13 – 18 played scotch. (Scotch: both players tee off on each hole. Pick best drive and alternate hits until ball is holed.) For NET scores use pops as they fall on Holes 1 – 6. On Holes 7 – 12 and 13 – 18, use  $\frac{1}{2}$  of the sum of both players' handicaps divided by 3.

### **2 MAN AGGREGATE SCORE:**

Total both NET scores.

### **2 Man Cha Cha Cha:**

Pop score card per assignment of strokes. Use one best ball on 1st hole, 2 best balls on 2nd hole. Repeat procedure through 18 holes. The total score of 36 best balls for gross score. Total the score of best balls with allocated pops for net score

### **2 MAN COMBINED SCORE:**

Each player on the team plays his own ball until completing the hole. Two scores are added together. Your adjusted gross score minus handicap strokes are added together per .

### **2 MAN CRISS CROSS:**

Stroke play. Choose the best 9 holes between front nine and corresponding holes on back nine. Example: 1 or 10, 2 or 11, etc. Subtract  $\frac{1}{2}$  handicap.



## Equitable Stroke Control (ESC)

### Equitable Stroke Control (ESC):

The following sets out the maximum strokes a player can post on any hole, whether a 3, 4 or 5 par, depending on the player's course handicap

Course Handicap	Maximum Score Posted on Any Hole
9 or less	Double Bogey
10 through 19	7
20 through 29	8
30 through 39	9
40 and above	10

Handicap	
01 - 18	Take strokes (pops) equal to your handicap, beginning with the #1 handicap stroke hole on the scorecard
19 - 36	Subtract 18 from your handicap. You are allowed two strokes (pops) per hole on however many strokes left over. <b>Example:</b> Handicap of 22: 22 minus 18 = 4. Take 2 strokes (pops) on the #1 handicap through #4 handicap holes. Take one stroke (pop) on all other holes
37 - +	Subtract 36 from your handicap. You are allowed three strokes (pops) per hole on however many strokes left over (calculated and distributed on holes as described above). Take two strokes (pops) on all other holes.

To determine your net score on a hole, subtract these “pops” from your gross score for that hole.

# RMGC Bulletin Board

- 1) The official RMGC bulletin board for RMGC is designated as the Washoe website [washoegolf.org](http://washoegolf.org) under the men's club tab.

## RMGC Match Play

- 1) RMGC Match Play is available for all RMGC members in good standing. Application forms are available in the Washoe pro shop. This tournament is coordinated by Greg Wenzel, (Head Golf Professional)
- 2) The flights are equal based on participation (Championship, First, Second, etc.) and divided by handicap.
- 3) The tournament is a double elimination format where if you lose your match you go to the losers bracket where you will play until you lose a second match.
- 4) The winner of the losers bracket in each flight will play the loser of the winners bracket final match to determine 2nd and 3rd place in that flight.
- 5) The winner of the winner's bracket is the flight winner.
- 6) The RMGC Board of Directors may allocate funds for flight winners (amount to be determined).

## Sierra Nevada Travel Cup Team

- 1) Members must be a member in good standing of RMGC and be approved by the RMGC Sierra Nevada Travel Cup team captain.
- 2) RMGC is the sponsor of the RMGC team in the Sierra Nevada Travel Cup. Competition format will be match play. The SNTC is comprised off 5 teams from various clubs, each team will consist of ten players. The Washoe team captain works in consort with the opposing team captain.
- 3) Matches are scheduled Home and Home on the second and third Tuesday of each month, alternating play at each member course.
- 4) One hundred percent of players most recent index will be used in which the competition is played and players will be matched according to index.
- 5) At each competition, points will be awarded for individual matches, team matches and overall team score. A total of 9 points are available for each four person match, and a total of 45 points are available for each days competition between the two teams.
- 6) At seasons end the team with the most points will be Champion and payouts will be awarded for the first thru fourth place teams.
- 7) RMGC has supported the Washoe travel team in the amount of \$500 per year. This amount is subject to review and approval annually by the RMGC Board of Directors.

## Tournament Points

- 1) RMGC will monitor and maintain a point standings for all RMGC members for RMGC scheduled tournaments. The standings will be available on the RMGC website [washoegolf.org](http://washoegolf.org).
- 2) Tournament points will be allocated in a manner similar to the PGA Fedex Cup. Any player participating will receive points based on where they place in the respective tournament.
- 3) The RMGC board has designated the four tournaments as Major Tournaments. Double points will be awarded for all Major Tournaments.
- 4) No points will be awarded for Wednesday scheduled tournaments

1. RMGC Opening Tournament (4/2/2016)
2. Individual Flight G/N (6/5/2016)
3. RMGC Club Championship Tournament (8/27-28/2016)
4. Closing Tournament Flight G/N (10/16/2016)

# SLOW PLAY

## Nine Ways to Improve Pace of Play

- 1. Move promptly:** Proceed quickly to your ball and be ready when it's your turn to hit.
- 2. Play promptly:** Take 30 seconds, maximum, to hit your shot.
- 3. Be quicker on the greens:** Read it. Hit it. Tap it in. Go to the next tee.
- 4. Treat the rules with discretion:** Take no more than 5 minutes to look for balls and take relief.
- 5. Do your housekeeping on your own time:** Start the round with tees, markers, balls and a ball-mark repair tool in your pocket. Replace head covers while you walk. Write down scores on the next tee. Don't make others wait.
- 6. Be cart smart:** Drop off your partner and drive to your ball. When you leave the cart, take three clubs, not one. Park behind greens.
- 7. Be a good teammate:** Know your playing partners' strengths and weaknesses; help them when it's convenient, move on when it's not.
- 9. Most of all keep pace with the group ahead.**

### Slow Play: Warning

RMGC members reported for slow play are subject to a two-stroke penalty and a verbal warning by the Rules Committee.

2nd Time: Written warning by Rules Committee

3rd Time: One-week suspension may be enforced

4th Time: Two-weeks suspension may be enforced
